Services that are provided include, but are not limited to, weekly group instruction focused on vocational education, computer literacy, creating resumes, assistance with filling out applications and part-time employment. Each student who is 14 or older has an Individualized Transition Plan (ITP) formulated by the IEP team. The ITP covers area such as financial responsibility, career interest, social-emotional development, and outside agency linkages. Each specified area in the ITP has a specific goal, as well as a designated individual who is responsible for measuring goal progress.
